



## **General Data Protection Regulation (GDPR) Compliance Document**

### **- Introduction**

STANWAY PEGASUS FC LIMITED C.I.C ("we", "our", "us") is committed to protecting and respecting your privacy. This GDPR Compliance Document outlines our practices regarding the collection, use, and disclosure of your information when you visit our website.

### **- Data Controller**

STANWAY PEGASUS FC LIMITED C.I.C is the data controller responsible for your personal data. If you have any questions or concerns about our use of your personal data, please contact us using the details provided at the end of this document.

### **- What Information We Collect**

We may collect and process the following data about you:

1. **Personal Identification Information**: Name, email address, phone number, and other contact details.
2. **Technical Data**: IP address, browser type and version, time zone setting and location, browser plug-in types and versions, operating system and platform, and other technology on the devices you use to access this website.
3. **Usage Data**: Information about how you use our website, products, and services.

4. **Marketing and Communications Data**: Your preferences in receiving marketing from us and your communication preferences.

- How We Collect Your Data

We use different methods to collect data from and about you, including:

1. **Direct interactions**: You may provide us with your personal information by filling in forms or by corresponding with us by post, phone, email, or otherwise.
2. **Automated technologies or interactions**: As you interact with our website, we may automatically collect Technical Data about your equipment, browsing actions, and patterns. We collect this personal data by using cookies, server logs, and other similar technologies.

- How We Use Your Data

We will only use your personal data when the law allows us to. Most commonly, we will use your personal data in the following circumstances:

1. **To provide and manage our services**: To deliver our services to you, including the management of your requests, applications, and transactions.
2. **To manage our relationship with you**: This includes notifying you about changes to our terms or privacy policy, and asking you to leave a review or take a survey.
3. **To improve our website**: To ensure that content from our site is presented in the most effective manner for you and your computer.
4. **To administer and protect our business and this website**: This includes troubleshooting, data analysis, testing, system maintenance, support, reporting, and hosting of data.
5. **To deliver relevant website content and advertisements to you**: And measure or understand the effectiveness of the advertising we serve to you.
6. **To make suggestions and recommendations**: About goods or services that may be of interest to you.

- Legal Basis for Processing Personal Data

We will only process your personal data where we have a lawful basis to do so. The legal bases for the processing we carry out are as follows:

1. **Consent**: Where you have given us explicit consent to process your personal data.
2. **Contract**: Where processing is necessary for the performance of a contract with you or to take steps at your request before entering into a contract.
3. **Legal obligation**: Where we need to comply with a legal obligation.
4. **Legitimate interests**: Where it is necessary for our legitimate interests (or those of a third party) and your interests and fundamental rights do not override those interests.

- Data Retention

We will only retain your personal data for as long as necessary to fulfill the purposes we collected it for, including for the purposes of satisfying any legal, accounting, or reporting requirements.

- Data Security

We have put in place appropriate security measures to prevent your personal data from being accidentally lost, used, or accessed in an unauthorized way, altered, or disclosed. In addition, we limit access to your personal data to those employees, agents, contractors, and other third parties who have a business need to know.

- Your Data Protection Rights

Under data protection laws, you have rights including:

1. **The right to access**: You have the right to request copies of your personal data.
2. **The right to rectification**: You have the right to request that we correct any information you believe
